## **Our Work**

The Trinity Foundation provides a means for Trinity members to live out our mission to be and make disciples of Jesus Christ.

Since its founding in 1971, the Foundation has granted over \$1.1 million to fund the needs of our church, educational opportunities for our youth and to support missions in our community and throughout the world. This work is made possible through the vision, commitment and generosity of those who have blessed the Foundation with their gifts. Much of this work is accomplished through endowed funds established by donors.

Significant grants in recent years include major gift support for the new church steeple and purchase of the church step van and new audiovisual system for the sanctuary. Undesignated gifts to the Foundation made these grants possible.

Annual grants include funding for adult, youth and children's missions, college scholarships and Dillard Forum programs. Periodic grants support staff development and other church needs. Earnings on endowed funds enable these gifts.
